Dear Applicant:

The City of Goodlettsville Beer Board has certain requirements, which must be met before an application can be considered for a permit.

Enclosed you will find the following:

- a) Application for City of Goodlettsville Beer Permit (must be filled out entirely and notarized).
- b) Corporate Authorized Representative Designation.
- c) Authorization for Criminal History Inquiry (must be filled out for **each person** having at least 5% ownership interest in the business). A copy of each person(s) driver's license must be submitted with this form.
- d) Complete copy of the City of Goodlettsville's Beer Ordinance for your review.

When you submit the above-completed forms, the following information must be attached:

- a) A copy of your recorded deed or executed lease agreement.
- b) A copy of your sales tax certificate from the State of Tennessee. If you have not received the certificate, it may be submitted within ten (10) days of the Beer Board meeting.
- c) A copy of your city and county business licenses.
- d) A copy of your seating chart for verification by the code enforcement office (if applying for an on-premise restaurant permit).

Applications are due three (3) weeks prior to the meeting date to be considered at the following month's Beer Board. A \$500.00 (non-refundable) filing fee must accompany all applications. The City of Goodlettsville Beer Board normally meets on the second Wednesday of the month at 9:00 a.m. in Massie Chambers, located at 105 S. Main Street, Goodlettsville, Tennessee. It is requested that each application have a representative present at the meeting. The pro-rated annual privilege tax will be due upon beer permit approval. You will need to bring a check for your annual privilege tax along with any previous permits that may need to be submitted at that time.

You will be informed of the exact meeting date and time.

I hereby certify that I have received a copy of the Goodlettsville Municipal Code Chapter 2 and that I have read the entire chapter and will oblige to all the regulations listed in the Goodlettsville Municipal Code Chapter 2.

I am knowledgeable of the laws prohibiting the sale of beer to minors. I hereby certify that no person having at least five (5%) percent ownership interest nor any person to be employed in the distribution or sale of beer in my establishment has been convicted of any violation of the beer or alcoholic beverage laws or any crime involving moral turpitude within the past ten (10) years.

By affixing its signature to this application, the applicant hereby authorizes the City of Goodlettsville to receive from each and every wholesale supplier to the permittee, the dollar value and amounts of beer sold by the wholesaler or distributor to the permittee, at such time or times as the City may request such information. This authorization shall be in full force and effect during the entire term of the permit.

I understand all property taxes, license fees and other charges owed by the permittee, or by the owners of the permittee, to the City of Goodlettsville or Davidson or Sumner County, Tennessee must be kept current throughout the term of the license. Failure to comply will result in the revocation of your beer license. This requirement shall not apply to the owners of a permittee that is a publicly held company.

Notice: A non-refundable \$500.00 fee for each type of permit requested must accompany this application. If the application is approved, you are required to provide documentation of sales tax registration to the City within ten (10) days of approval. Any applicant making false statements in this application shall forfeit his permit and shall not be eligible to receive any permit for a period of ten (10) years.

A privilege tax of \$100.00 for each type of permit is imposed on the business of selling, distributing, storing, or manufacturing beer in this state effective January 1, 1994 and each successive January 1. Any holder of a beer permit issued after January 1st shall pay a pro rate portion of this annual tax when the permit is issued.

Please check the appropriate boxes for each permit desired. Permits may be stacked on top of each other to provide all beer related sales you are interested in providing. You may request all required permits on a single application. It is the applicant's responsibility to be aware of all requirements for the permits they are holding. A copy of the ordinance is provided with the application. A few specific requirements are spelled out below and **must be initialed as assurance the applicant is aware of all conditions that are required under the ordinance.**
